

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Madeleine Walker Coastal Ballet Theater, LLC ("Ballet Theater") has put in place preventative measures to reduce the spread of COVID-19; however, the Ballet Theater cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the Ballet Theater could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the Ballet Theater and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Ballet Theater may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Ballet Theater employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Ballet Theater or participation in Ballet Theater programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Ballet Theater, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Ballet Theater, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Ballet Theater program.

Consent

- I agree to follow all safety instructions given by the teachers and staff during my complimentary private studio time.
- I agree not to attend any class if the student or any member of the household is sick or has cold or Flu symptoms
- I agree to qualify for complimentary lessons in the studio I will attend all regular Zoom classes as provided by Madeleine Walker Coastal Ballet and understand that students may not miss more than 2 Zoom sessions during a monthly session.
- I agree to continue regular monthly tuition.

- I agree to have my temperature taken upon entering the studio area and to use hand sanitizer provided by the studio.
- I agree to wear a mask of my choice at all times before entering the studio, during my lesson and exiting the studio.
- I agree to arrive 5 to 10 minutes before my class session begins and wait in my car until clearance is given to enter the studio. I agree to have my transportation waiting 5 to 10 minutes before my session ends, exiting the studio immediately after the lesson.
- I agree to arrive dressed with hair up wearing regulation leotard and pink convertible tights and use the plastic bag provided by the studio to transport my dance shoes. No dance bags or additional clothing will be allowed in the studio.
- I agree to leave my slip off shoes at the door in the designated area.
- I agree to use bathroom facilities only in emergency and will be responsible to take care of personal needs before leaving home and entering the studio. By doing so I agree to help the staff keep cleaning and sanitizing to a minimum.
- I agree no one other than staff or dancers will be allowed to enter the studio.
- I have reviewed and agree with all material provided and I have watched the video explaining Madeleine Walker Coastal Ballet Covid 19 rules and regulations.*
- I am a parent or guardian 18 years or older.
